Eligibility

The show is open to artists 18 and older who are residents of Brunswick County or who are paid members of the Associated Artists of Southport, Oak Island Art Guild, Waterway Art Association, Coastal Carolina Camera Club or the Brunswick Arts Council.

Conditions

Entries must be original works, not previously shown at the BAC Annual Fall Exhibition. Ceramics, drawing, painting, photography, printmaking, sculpture, or a combination of the listed media created in the last four years (2016 - 2020) will be considered. 2D art works must be suitably framed and securely wired ready to hang. 2D entries 30" or larger must be framed under plexiglas. All entries must not exceed 40" in any direction. 3D work must not exceed 50 pounds. No entry that requires the artist to be present for moving or assembly will be accepted.

Entry Fee

A maximum of two art works are allowed per Artist. Submit a non-refundable entry fee of \$35. Make check payable to: Brunswick Arts Council. (see entry form)

Sales

Artists will receive 100% of sales price. Works may be listed as *Not For Sale*.
